



## Revisions to T.D.O.T. Design Division Standard CADD Files

### July 2016 Update

#### **BEFORE YOU DOWNLOAD THE UPDATED EXE FILES...**

Some files need to be deleted or relocated. This is necessary to reduce any questions and confusion. The following are batch files created to take care of the old files that need to either be deleted or relocated. Each link downloads to a "Batch EXE Files" folder located here: "[C:\Users\Public\Batch EXE Files](#)". You **must** go there and execute the batch file(s) by double-clicking on each file. A brief explanation of each batch file is as followed:

- **DeleteOldFiles.bat** – This batch file deletes the following files because they are being replaced:
  - English EPSC Special Notes.dotx – The new word document file has a date extension added for revision purposes. The new EXE file will not overwrite the old file.
  - English General Notes.dotx – The new word document file has a date extension added for revision purposes. The new EXE file will not overwrite the old file.
  - English Index & Std Dwgs.dotx – The new word document file has a date extension added for revision purposes. The new EXE file will not overwrite the old file.
  - English Drop Off Notes.dotx – The new word document file has a date extension added for revision purposes. The new EXE file will not overwrite the old file.
  - ROW Notes.dotx – The new word document file has a date extension added for revision purposes. The new EXE file will not overwrite the old file.
  - EnglishEPSCSpecialNotes.dgn – The new seed file has a date extension added for revision purposes. The new EXE file will not overwrite the old file.
  - EnglishGeneralNotes.dgn – The new seed file has a date extension added for revision purposes. The new EXE file will not overwrite the old file.
  - Ind&StdDwgsEng.dgn– The new seed file has a date extension added for revision purposes. The new EXE file will not overwrite the old file.
  - EnglishDropOffNotes.dgn – The new seed file has a date extension added for revision purposes. The new EXE file will not overwrite the old file.
  - Phase Stamp - P S & E Review.jpg – Replaced by Phase Stamp - Final Construction Plans Review.jpg
  - Phase Stamp - Hydraulic Grade Approval.jpg – Replaced by Phase Stamp - Initial Request.jpg



- **MovingAllMetricFiles.bat** – Since there are some metric files awaiting R.O.W or Construction phase, the metric files will not be deleted. However, they will be relocated to “C:\Users\Public\Old Metric Files (No Longer Updated)”. This way if anybody needs to use anything concerning metric file, they will be here. But please note the name; metric files are **no longer updated**. So keep that in mind.

The next six batch files depend on which setting files you used before now. Please note that the batch file searches for the location of the settings file (C:\Users\Public\InterPlot Standards\Settings) and places them here (C:\Users\Public\InterPlot Standards\Old Setting Files). Please note, if your setting files are in a different location, the batch file **will not work**.

- **RelocateSettingFilesConsultant.bat** – This batch file is for **consultants**. It targets the “Setting” and “STD” plotting files used.
- **RelocateSettingFilesHQ.bat** – This batch file is for **Headquarters**. It targets the “12<sup>th</sup> floor”, “13<sup>th</sup> floor A” “13<sup>th</sup> floor B” and “STD” plotting files used.
- **RelocateSettingFilesReg1.bat** – This batch file is for **Region 1**. It targets the “Setting” and “Region 1” plotting files used.
- **RelocateSettingFilesReg2.bat** – This batch file is for **Region 2**. It targets the “Setting” and “Region 2” plotting files used.
- **RelocateSettingFilesReg3.bat** – This batch file is for **Region 3**. It targets the “Setting” and “Region 3” plotting files used.
- **RelocateSettingFilesReg4.bat** – This batch file is for **Region 4**. It targets the “Setting” and “Region 4” plotting files used.

### **Settings.exe...**
