The CADD file is an updated version that has areas labeled that correspond to the videos as well as the PDF report of the videos previously provided. These videos include areas in which data was lost but the videos were retained, areas in Priority 1, and areas in Priority 2. Areas in which data is being collected again are shown in red. Areas that have data and video are shown in blue. There are several items to note from the videos: • In your newly named Priority F and Priority G locations the trunk line appears to be higher than the lateral pipes. • NRMH1 to NRCB3 (Storm 10) has a pipe stubbed into the trunk line at approximately station 1322+65. This was left off the report and is not on the survey from TDOT.
