There are several items to note from the videos: Video WE7 to WE8 found a pipe connection that was not in the survey. It is at approximately station 1042+40. Video JB8 to JB7 found a JB that was not on the survey at approximately station 1066+64. Video WE13 to JB11 found a pipe that was not in the survey and was not in the Report PDF at approximately station 1076+87. Video WE13 to JB11 shows 3 pipes flowing into JB11. To see this accurately you will need to use the paper plans from TDOT as well as the survey dgn. Only one was picked up on each.
