CONSENT TO EASEMENT STRUCTURES

MHEREAS, the Government has acquired a flowage easement over the above listed treet of lend by virtue of deed of record in the Office of the Recorder of Baith County, Tennessee, which easement, by its terms, reserves to the Government the right of prior approval of any structures that may be constructed and mainteined on the lend.

WHEREAS, the State of Tennessee, Department of Highways, has acquired, or is in the process of acquiring, from the Landowner of the above tract an easement or fee title for right of way for the construction and maintenance of an access road under the existing Interstate Highway I-40 bridge over Caney Fork at River Mile 20.7 to provide access to a proposed safety rest area located in the vicinity thereof, shown in red on Exhibit "A" attached hereto, and designated by the Tennessee Highway Department as "Project: LSI-40-5(5) 268. Safety Rest Area 17W, Smith Gounty".

WHEREAS, the aforesaid access road will require construction on the land which must be approved by the Government in writing.

NOW THEREFORE, by virtue of the authority vested in the Government under the terms of the Plowage Easement, consent is hereby given to the construction of the aforesaid access road which shall be in accordance with the attached drawing, Exhibit "A", reviewed and approved on behalf of the District Engineer, U. S. Army Engineer District, Nashville. It is to be understood, however, that this consent is effective only insofar as the rights of the United States in the property over which the casement structure is to be extended are concerned, and that the State of Tennessee, Department of Highways, shall obtain such permission as may be necessary on account of any other existing rights. Also, this consent shall not preclude the State from obtaining appropriate right of way from the owner of the uncerlying fee title.

PROVIDED, HOWEVER, that this consent does not preclude the necessity of obtaining the permit required by Section 10 of the Act of 3 Merch 1899 (30 Stat. 1151; 33 U.S.C. 403). FURTHER, this consent is subject to the right of the United States to flood said rights of way as may be necessary by the construction, operation and maintenance of the Center Hill Dam and Reservoir Project.


