In compliance with the provisions of Public Chapter No. 517 of the Public Acts of 1988, the Tennessee Department of Transportation (TDOT) Utilities Office has completed the required notifications to all known utility owners operating within the vicinity of the proposed project.

Working in coordination with the TDOT Utilities Office, Neel-Schaffer, Inc. has compiled this document to identify the preliminary utility facilities that may be impacted by the construction activities associated with this project. While the information provided herein represents the best available data at this stage, it should be understood that it may not encompass every utility located within the project footprint. Accordingly, it will be the responsibility of the selected construction team to verify the presence, type, and location of all utilities within the defined project limits prior to beginning construction.

It is also important to note that not all utility owners have provided responses to TDOT's initial notification regarding their facilities. Of particular significance, Colonial Pipeline has not yet submitted confirmation regarding the status or location of its infrastructure in the project area. This underscores the necessity for continued communication and coordination among TDOT, the selected contractor, and affected utility owners, businesses, land owners and Developers to ensure that all facilities are properly identified, protected, and accommodated during the construction process.









General location of two petroleum pipelines














