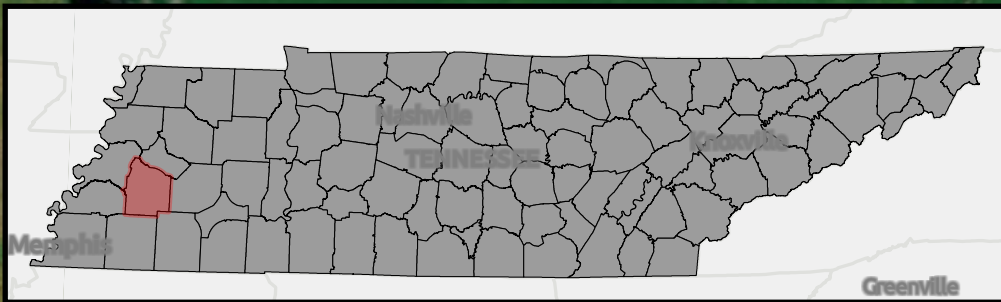

HAYWOOD COUNTY

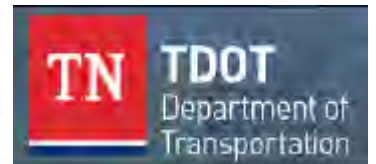

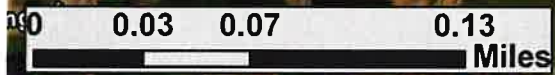
