
while continuing to deliver a safer, more efficient transportation system for Tennessee.

- Meet our new Statewide Proficiency Program Coordinator Jinney Settles. Jinney has a strong background in employee training, virtual facilitation and program monitoring, and is excited about creating engaging and relevant learning experiences that enhance performance and retention.
- Meet our Transportation Worker Proficiency Program Alignment Team! This team consists of a cross-section of maintenance representatives from each region and headquarters that works hand-in-hand with Jinney on developing and improving the modules within the Worker Proficiency Program.
- Senior-level employees and above who will be assisting in administering ProPath must complete a one-day Competent Observer Training. Discover upcoming dates and what to expect from this training.
- Updates to the ProPath Procedures Manual for Transportation Workers were released on April 15, 2024, including eligibility for automatic grandfathering, new elective modules, order of operations for module certification and other procedures.
