The TDOT Environmental Mitigation Office is responsible for providing compensatory mitigation to offset stream and wetland impacts from transportation projects through a process referred to as compensatory mitigation. Compensatory mitigation methods include restoration or rehabilitation, establishment, enhancement, and/or preservation of wetlands, streams and other aquatic resources for the purposes of offsetting adverse stream and wetland impacts.
