## Environmental Division Technical Studies Office Cultural Resources Section Archaeologist TDOT Location: Nashville, TN

### Overview

The Tennessee Department of Transportation (TDOT) Environmental Division Technical Studies Office is currently hiring a full-time Archaeologist in the Cultural Resources Section in Davidson County.

The Cultural Resources Section is a vital part of TDOT's Project Development and Delivery processes as well as operation and maintenance of existing facilities. The Section is responsible for ensuring compliance with the Section 106 of the National Historic Preservation Act, Section 4(f) the U.S. DOT Act, and T.C.A. 11-6. The Section identifies and assesses effects to historic architectural and archaeological resources within a TDOT project area and conducts interagency coordination and consultation with state and federal agencies. TDOT Archaeology works with the project designers to avoid and minimize impacts to archaeological resources. TDOT Archaeology consults with the State Historic Preservation Office, the TN Division of Archaeology, and Consulting Parties throughout project development.

### Responsibilities

- Ensuring compliance with the Section 106 of the National Historic Preservation Act, Section 4(f) the U.S. DOT Act, and T.C.A. 11-6.
- Develop and review archaeological survey reports.
- Conduct interagency coordination and consultation with state and federal agencies for archaeological resources on TDOT projects.
- Work with the project designers to avoid and minimize impacts to historic archaeological resources.
- Assist with development of written processes, training, and QA/QC for project deliverables.
- Educate and help TDOT staff outside the Cultural Resources Section understand state and federal statutes, rules, and regulations for archaeological resources.

### Qualifications

#### Education and Experience

An ideal candidate would have a graduate degree in archaeology, anthropology, or closely related field with demonstrated experience conducting archaeological surveys, documenting those findings in reports, and conducting interagency consultation and coordination with state and federal agencies. The candidate would also possess the needed education and experience to meet the Consultant Qualifications in the TN SHPO Standards and Guidelines for Archaeological Resource Management Studies.

Substitution of Education for Experience: Graduate coursework may be substituted for the required experience on a year-for-year basis, to a maximum of two years (24 semester hours is equivalent to one year). Substitution of Experience for Education: None.
