## Overview

The Right-of-Way (ROW) Division is responsible for acquiring and managing all right-of-way needed for the construction and maintenance of highways in the State of Tennessee. The ROW Division provides relocation assistance for displaced families and businesses in accordance with the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 when necessary for State highway construction. The Division also coordinates utility relocation and the disposition of State owned surplus real property.

## Responsibilities

The Right-of-Way GTA will work in the Utilities Office which is responsible for the coordination of local utility and railroad relocation efforts for highway construction and issuance of utility encroachment permits. The GTA's responsibilities include initiating and coordinating projects with Railroad involvement and assisting the State Railroad Coordinator with delivering projects to letting and aiding in the development of a crossing inventory database. Additionally, the GTA will oversee the LPA Railroad program and certification of all LPA projects.

## Qualifications

A Bachelor's or Master's degree in Civil Engineering is required. Additionally, the GTA must pass the Fundamentals of Engineering (FE) Examination within eleven months of employment.

The ideal GTA candidate will have an interest in railroad coordination, have strong communication skills and comfortable communicating with internal and external business partners.
