Railroad Safety Manager (Transportation Manager 1)

TDOT Headquarters

Location: Nashville, TN

Compensation Range: \$5,483-\$8,772 per month

Overview

The Tennessee Department of Transportation is currently hiring a full-time Railroad Safety Manager professional for our TDOT headquarters location in Davidson County, and serving our Middle Tennessee area.

The Railroad Safety Manager is a part of the TDOT Freight and Logistics Division. The Freight and Logistics Division provides leadership on issues of rail, water, and highway freight.

Responsibilities

Manages a staff of four railroad safety inspectors and safety specialist covering various sections of the state of Tennessee. Management responsibilities include division of work duties, performance reviews, submission of monthly FRA and state reports, approval of reports, and approval of payroll and expense accounts for inspectors.

Reviews records (e.g., hours of service, accident histories, inspection reports) and observes/monitors operating practices (e.g., loading, switching, general railroad operations) to verify compliance with safety regulations, including blue flag rules, alcohol and drug use policies, and rear end marking device regulations.

Performs state inspections of railroad crossings, rail yards, industrial sites, and other rail-accessible areas to ensure railroad crossing compliance with state railroad safety regulations (e.g., minimum overhead and side clearances, minimum distances between tracks, proper drainage).

Investigates complaints concerning railroads and railroad accidents and derailments to determine cause and identify any possible or resulting hazard.

Writes federal and state inspection reports detailing results of inspections and investigations.

Required to achieve and maintain federal certification by attending out-of-state training conducted by FRA-certified federal inspectors.

Will require overnight travel.

Qualifications

Graduation from an accredited college or university with a bachelor's degree and experience equivalent to five years of full-time professional work in railroad operations and/or railroad safety. At least two of the required five years must be supervisory or higher experience. Qualifying experience may substitute for the required education on a year for year basis to a maximum of four years.

Possession of Federal Railroad Administration (FRA) certification and/or some training in FRA practices would be preferred.
