Overview

The Tennessee Department of Transportation is currently hiring a full-time Construction Project Manager-Trainee for our Hamilton County construction office. After a one-year probationary period, the trainee will promote into working-level job classification and receive a salary increase.

TDOT is comprised of 4 regional locations, with each being responsible for construction operations in their respective locations. Other key responsibilities include management of project processes and status to ensure timely and fiscally responsible delivery of state highway transportation projects adhering to state and federal rules and regulations.

Responsibilities

Manages construction projects including reviewing schedules and tracking expenditures to ensure Department goals are met

Oversees inspection staff to ensure projects are constructed in accordance with plans and specifications

Facilitates communication between the Department, contractors, and stake holders by writing letters, conducting meetings, etc. to ensure accurate information is conveyed in a timely manner
