Overview

The Project Development Director is responsible for managing the administrative, engineering, and technical activities of the Regional Project Development Office that is responsible for twenty four counties in Region 2. This position is responsible for policy, community outreach, design, right-of-way acquisition, utility relocation and special projects.

This is an Executive Service Position that reports to the Director/Assistant Chief Engineer of Region 2. The position manages two direct reports and is responsible for a staff of almost 100 employees who work in the Region project development teams.

Responsibilities

Manages overall leadership and direction for the project development engineering, technical, and environmental teams including the coordination of project scheduling and the division's budget.

Oversees roadway design, right-of-way, utility relocation, and survey projects. Monitors progress to ensure timely and fiscally responsible project delivery.

Maintains relationships with local, state, and federal partners to advance the business objectives of the Region and TDOT.

Provides oversight of special projects including development and administration of the Regional Pavement Management program.

Reviews recommendations regarding necessary safety projects and other roadway improvement projects that could improve the flow of traffic.

Interacts with Division Directors, Chief Engineer, Community Relations, Bureau of Environment and Planning, Bureau of Administration and Commissioner's Office to develop or improve existing policies and procedures.

Qualifications

The minimum required knowledge, skill, and abilities to satisfactorily perform the job duties are normally acquired through graduation from an accredited college or university with a bachelor's degree in civil engineering and six (6) years of related transportation engineering and management experience. At least three (3) years of supervisory experience and a **Professional Engineering License is required**.

Candidates should have a foundation of strong civil engineering/roadway design skills and possess an extensive understanding of the entire project delivery process.
