#### Overview

The Tennessee Department of Transportation is currently hiring student interns to work in the Construction offices located in Harriman, LaFollette, and Maryville, TN. The Construction interns will get a chance to work in the field to see the process of milling, paving, striping, and signing the roadway, an interstate paving project, stream mitigation, and a ramp widening. These interns will complete detailed Daily Work Reports, written correspondence, and any other documentation for the project necessary to detail the work taking place. These interns will also develop a presentation to regional leadership demonstrating what you have learned.

### Responsibilities

- Assist District Specialists with paperwork, surveying, measuring quantities, etc.
