#### Overview

The Tennessee Department of Transportation is currently hiring student interns to work in the regional Construction offices located in McKenzie and Newbern, TN. The interns will be paired with an inspector in the field to obtain knowledge of construction activities that are related to inspection duties and documentation for construction activities. The interns will gain knowledge of the contractor role and TDOT inspector role by learning how they work together to complete the state contract work. In addition, these interns will sit in on a preconstruction conference.

#### Responsibilities

- Conduct site inspections on local, active construction projects.
- Assist in the preparation of documents necessary for payments to contractors.
- Assist in performing environmental and traffic inspections on active jobsites.
- Review the Critical Path Report for a contract each month. A report will be generated detailing their findings in the CPM and its documents verses what work the contractor has performed that month.
- Become familiar with TDOT specifications, Materials and Tests Standard Operating Procedures, Construction Plans, and the different challenges that arise on a daily basis in the field.
- Assist field staff to learn the day to day operations of a District Construction office.
- Lead the lane closure meetings and keep notes for the preconstruction conferences and weekly jobs update meetings to compose an email to be sent out to field and office staff to keep them advised. Attend preconstruction conferences with the contractor and TDOT staff to be held either in person or via Microsoft Teams.
