## **Job Overview**

The Statewide Technical Specialist – Field Services Compliance, supports the implementation of innovative concepts that improve performance and increase the sustainability of TDOT's transportation system by evaluating compliance with Federal and State environmental permits and regulations as part of TDOT construction activities. This position administers the program consistent with Federal and State statutes, regulations, policies, and guidance. The Statewide Technical Specialist - Field Services Compliance role requires collaboration with both internal and external partners to develop environmental policies, procedures, standards, manuals, and related training for TDOT.

The Statewide Technical Specialist - Field Services Compliance ensures Department policies, technical guidance, procedures, software, and systems are current and accurate to meet federal and state requirements. This position assists in implementing the Quality Assurance Program as part of the Environmental Division activities. The Statewide Technical Specialist - Field Services Compliance assists with monitoring and managing the scope, schedule, and budgets of all environmental Field Services-related activities and works with the environmental compliance staff located in the regions as necessary to ensure that the work completed is in alignment with the Environmental Division's goals.

#### **Essential Job Responsibilities**

Perform Quality Assurance (QA) Inspections on construction projects with National Pollutant Discharge Elimination System (NPDES) Construction Stormwater Permit coverage with land disturbance greater than one acre. Inspect each project one to two times per month.

Perform QA inspections on construction projects with the Tennessee Department of Environment and Conservation (TDEC) Aquatic Resource Alteration Permits (ARAP), as needed.

Coordinate construction project compliance oversight activities with the Tennessee Department of Environment & Conservation (TDEC) and other regulatory agencies related to the NPDES Construction Stormwater Permits, ARAP Permits, U.S. Army

Corps of Engineers (USACE) 404 Permits, and Underground Injection Control (UIC) Class V (Sinkhole) Permits.

Participate in any inspections conducted by federal, state, or local regulatory agencies.

Prepare QA Inspection Reports and upload to compliance database.

Develop guidance documents and provide technical expertise and training on matters relating to Erosion Prevention & Sediment Control (EPSC).

Participate in the Project Teams as part of a matrix organization consistent with the PDN, delivering all products and services as required and providing input at all applicable project milestones, including Project Kick-Off, Risk Workshops, Project Scoping Meetings, Field Reviews, and Plans, Specifications, and Estimates meetings.

Provide exceptional customer service to both internal and external customers, including mentoring and technical guidance, coordinating with other disciplines as part of a matrix organization, exercising effective listening skills, providing prompt responses, maintaining complete and accurate documentation, and communicating effectively.

Assist in the development of training related to t Field Services Compliance requirements, analysis, and documentation that addresses acquired knowledge, asset management objectives, risk management, technical design elements, and emerging technologies related to transportation for the purpose of improving team performance, creating a stronger understanding of the transportation industry, inspiring new ideas, and developing skills.
