Overview

The Tennessee Department of Transportation is currently hiring a student intern for the Region 4 Utilities office located in Jackson, TN. The intern will assist the Region 4 Utility Office staff with preliminary utility relocation estimates, review A-Date plans package to ensure submissions meet the requirements of the utility relocation manual. The intern will review functional design plans to determine areas of conflict and provide suggestions for remediation (Design Changes or Utility Relocation). The intern will be responsible for providing justification on how and why their suggestions would impact project scope and schedule. They will also be exposed to Project Delivery Network and learn to work within a matrix organization comprised of various teams with differing disciplines.

Responsibilities
