Transitioning to the PDN

With Integrated Program Delivery, or IPD, our employees will deliver our programs and projects by integrating project teams, systems and business structures to leverage resources, including insights and innovation, to improve efficiency and maximize outcomes. IPD is our way of doing our jobs. One key element of IPD is the PDN which focuses on providing a simplified, automated "roadmap" for our project delivery workflows. The PDN's goal is to have a network that is easy to understand and manage, that accelerates activities, can measure performance and produces efficient delivery at all levels. The PDN also allows all employees involved in the project delivery process from planning through letting to have a better understanding of the entire process.

Starting October 2, 2023, all active projects that have not made it to the right-of-way phase will complete all stages of the PDN. Projects that have completed the right-of-way phase will only complete stage three and four of the PDN, only tracking key activities.

Any current design managers assigned to an active legislative project will have a project manager assigned to those projects by October 2, 2023. Design managers assigned to active program projects will continue to manage those projects until the Project Management Division is fully staffed. A transition plan will be developed to transition project managers to assume the project management roles currently designated to the design managers. Current design managers will remain a resource to the newly assigned project managers.

On-system and Off-system Bridge Work Program

At the end of June 2023, we shared our three-year work program (2024-2026) for both on-system and off-system bridges with Executive staff, Directors and Managers of offices that influence project delivery. Both work programs list the bridge replacement projects employees will be focusing on. This helps with understanding your workload, and answers the question "What's next?" regarding bridge replacement projects. The Bridge Work Programs has been published to our website here.
