This position will ensure the implementation of the quality assurance program to achieve program efficiency and effectiveness. The Team Lead will supervise technical staff and implement performance plans, schedules, and budgets, ensuring each team member's expected outcomes, performance, and accountability. The Team Lead will research national best practices to drive innovation and efficiency within the Freight Planning & State Safety Oversight Team.

Essential Job Responsibilities

Manage resources and staff utilization and assist the Freight Planning & State Safety Oversight Team in performing their roles effectively and efficiently, optimizing the Team's ability to administer freight planning and State Safety Oversight processes successfully.

Lead the statewide freight planning program, including assisting with administering and managing Tennessee's National Highway Freight Program, statewide freight plan, statewide freight advisory committee, collaborating with transportation agencies and public and private partners to coordinate freight efforts, and providing freight planning support to Metropolitan Planning Organizations (MPO) and Rural Planning Organizations (RPOs) by providing freight data and assisting with freight plans and projects.

Lead the administration of the Short Line Preservation Grants Program, including initiating and executing contracts, processing invoices, coordinating effectively with rail authorities throughout the project development and construction processes, scheduling construction project final inspections, and ensuring contracts and purchase

orders are closed out when projects are completed.

Lead the oversight of Rail Fixed Guideway Systems (RFGS) for rail transit agencies (RTAs) not regulated by the FRA in the State of Tennessee, including conducting Triennial Reviews of RTAs, reviewing and approving the State Safety Program Standard, Agency Safety Plans, Agency Internal Safety Reviews, Corrective Action Plans, and preparing and providing annual reports to the FTA, the Governor, and RTA Boards of Directors.

Lead the Freight Planning & State Safety Oversight Team in providing exceptional customer service to internal and external customers, exercising effective listening skills, providing prompt responses, maintaining complete and accurate documentation, and communicating effectively.

Establish and ensure there is a direct relationship between quality and work outcomes by developing and implementing quality control and quality assurance processes for the Freight Planning & State Safety Oversight Team's freight planning and State Safety Oversight activities.
