Job Overview

The Metropolitan Planning Organization (MPO) Team Lead will manage, mentor, and train the Community Transportation Planning MPO Team through empowerment, communication, and delegated authority. This position will develop work plans that align with TDOT's strategic vision and will effectively delegate authority and responsibility while ensuring the availability of resources for the Community Transportation Planning MPO Team to be successful.

The MPO Team Lead will also manage the development and implementation of departmental policies, discipline-specific technical guidance, procedures, and manuals related to community transportation planning for incorporation into TDOT's programs and projects. This position will ensure the implementation of the quality assurance program to achieve program efficiency and effectiveness. Furthermore, the MPO Team Lead will supervise technical staff and implement performance plans, schedules, and budgets, ensuring expected outcomes, performance, and accountability of each team member; and will research national best practices to drive innovation and efficiency within the Community Transportation Planning MPO Team.

Essential Job Responsibilities

Manage resources and staff utilization and assist the MPO Team so they can perform their roles effectively and efficiently, optimizing the Team's ability to successfully administer metropolitan transportation planning processes.

Lead MPO Program Oversight through a continuing, cooperative, and comprehensive performance-based statewide multimodal transportation planning process and perform liaison duties between local agencies, the Federal Highway Administration (FHWA) and TDOT including assisting in developing and coordinating the FHWA and TDOT review of Unified Planning Work Programs (UPWP), Public Involvement Plans, Transportation Improvement Programs (TIPs), Long Range Transportation Plans, and Title VI and Civil Rights documents; disseminate federal discretionary grant program information, provide funding information to the MPOs local agencies for projects that have been programmed in the TIPs; respond to all planning-related inquiries from MPOs and local agencies; coordinate the development of Corridor Management Agreements; serve on MPO Boards and MPO Technical Committees; and present information at MPO Board and other local meetings.

Engage with external partners and which will include developing and advising on internal/external contract scopes of work, negotiating contracts/grants, reviewing

consultant contract/grant invoicing, managing contract/grant tasks, and monitoring consultant performance.

Lead the MPO Team in providing exceptional customer service to both internal and external customers, exercising effective listening skills, providing prompt responses, maintaining complete and accurate documentation, and communicating effectively. Establish and ensure there is a direct relationship between quality and work outcomes by developing and implementing quality control and quality assurance processes for the MPO Team with respect to MPO planning activities.

Assist with the management of the policy direction for the MPO Team as part of a matrix structure, creating policies, procedures, guidelines, and performance metrics that support adherence to federal and state requirements, include best practices, and improve planning processes. Assist with the financial performance for the MPO Team in alignment with TDOT financial processes to ensure transparency and accountability.

Manage change and conflict, clarify the vision, take ownership of the change, communicate effectively, remain transparent, lead by example, and hold yourself and others accountable throughout the process.

Ensure the MPO Team remains current on national best practices as it relates to metropolitan planning processes and procedures; incorporate research, evaluations and implementation of emerging processes and technologies into the Community Transportation Planning responsibilities that will improve efficiency, resiliency, effectiveness, reliability, sustainability, and the safety of Tennessee's transportation network; integrate federal and state requirements into TDOT's guidance documents, processes, and procedures. Participate in peer exchanges with State and local governments and applicable industry partners for key insights and collaboration.

Provide oversight in the development of the MPO Team deliverables, and ensure they are consistent, predictable, and repeatable to provide consistently high levels of achievement, mitigation of risk, and an established track record of success.
