#### Who we are:

# Metropolitan Planning Organization (MPO) Technical Specialist Planning Division – Community Transportation Planning Section \$60,600 - \$70,680 annually

## Job Overview

The Metropolitan Planning Organization (MPO) Technical Specialist will support Planning by serving as TDOT's primary point of contact with local governments in the urbanized areas and performing liaison duties with local agencies, TDOT, and the Federal Highway Administration (FHWA) for planning-related matters. This position is responsible for administering the Planning (PL) funding program and for leading and coordinating the TDOT and FHWA review and approval of all MPO core Federal documents including Unified Planning Work Programs (UPWPs), Public Participation Plans, Statewide Transportation Improvement Program (STIP), Transportation Improvement Programs (TIPs), Long Range Transportation Plans (LRTPs), and Title VI and Civil Rights documents.

This position supports the administration and delivery of transportation planning projects and programs for the MPOs. The MPO Technical Specialist maintains a strong understanding of TDOT project development processes and stays informed on Department-related activities and project status. They communicate this information clearly to local governments and the public to support successful execution of the Department's Work Program. The MPO Technical Specialist coordinates planning efforts across rural Tennessee, ensures timely follow-up on projects, and collaborates effectively within a matrix organization and with external stakeholders to articulate planning concepts and priorities. The MPO Technical Specialist also participates in training activities to build subject matter expertise and support the consistent application of planning practices across the state.

#### Essential Job duties of Technical Specialist I, II, and III include:

Coordinate the review of MPO and local governments' transportation plans, studies, and related planning products with other TDOT Divisions, Federal agencies, other state and local agencies, and the public, as required. Actively participate in transportation studies coordinated by MPOs and local municipalities, including assisting in the development of bicycle/pedestrian plans, corridor studies, and other transportation planning products.

Maintain a transportation funding database that includes all transportation-related funding opportunities. Inform MPOs and local partners of Federal grant availability, including grant requirements, Notices of Funding Opportunities (NOFOs), eligibility requirements, application guidance, and other pertinent grant information.

Serve as TDOT's representative on MPO Executive Boards and Technical Committees. Present project-related information at local agency and public meetings. Participate in local agency workshops and project public meetings and hearings. Track and report on MPO activities.

Provide exceptional customer service to project stakeholders by facilitating the sharing of project information that is organized and understandable to technical staff and the general public. Exercise effective listening skills, provide prompt responses, and communicate effectively. Promote transparency, responsiveness, and clarity by removing barriers to communication and maintaining well-organized documentation.

Implement policies, standards, guidance, and a data management system that promotes statewide uniformity and consistency of Community Transportation Planning Section deliverables. Implement records retention policies for use and compliance with Records Disposition Authorization (RDA) requirements.

Research and implement emerging processes, procedures, and technologies that improve the efficiency, effectiveness, reliability, sustainability, and safety of TDOT's transportation network. Stay current on national best practices, regulatory changes, and peer agency innovations.

Review and approval of MPO invoices to ensure the effectiveness of the MPO's planning staff in carrying out their responsibilities as agreed to in the approved Unified Planning Work Program (UPWP).

Assist in the administration of metropolitan transportation planning grant activities by supporting documentation tracking, organizing project files, and compiling basic information for reports. Participate in coordination meetings with local governments and TDOT staff to observe and learn about the implementation of federal planning grant programs and Corridor Management Agreements.

Develop and maintain relationships with local government officials, regional, and planning staff across metropolitan areas to promote long-term engagement with the statewide transportation planning process.

Coordinate and facilitate aspects of the federal certification process for MPOs designated as Transportation Management Areas (TMAs) by serving as a liaison between the MPO TMAs and federal partners. Support the certification of non-TMA MPOs to ensure alignment with federal planning requirements.

#### Additional Job duties for the Technical Specialist II and III include:

Administer TDOT Transportation Planning Grant program and other grants. Coordinate with local governments and FHWA regarding implementation issues of awarded Federal planning grants. Develop and implement Corridor Management Agreements which coordinate land use and transportation planning. Conduct annual MPO conferences regarding updates on policies and procedures and best practices for processes and documents.

Contribute to the development and implementation of policy for consultant submittal requirements and compliance with state and federal procurement regulations.

Assist with preparing and delivering presentations at RPO meetings, workshops, or webinars. Support in communicating planning processes, grant updates, and program information to internal and external stakeholders.

Evaluate MPO meeting content, participation, and outcomes to recommend enhancements to meeting formats, agendas, or outreach strategies that improve engagement and transparency.

Identify funding or technical assistance opportunities to support high quality planning and meeting work program milestones.

Collaborate with TDOT Communications or Public Involvement teams to improve accessibility of metropolitan planning materials and public outreach campaigns.

Review MPO planning activities and documentation to support the federal certification of Transportation Management Areas (TMAs). Evaluate whether the TMA is meeting federal planning requirements, assist in the preparation of certification findings, and provide technical feedback to MPO partners. Contribute to identifying areas of non-compliance and recommending corrective actions or process improvements.

# Additional Job Duties for the Technical Specialist III include:

Provide training to Headquarters and Region leadership and staff related to planning requirements, analyses, and documentation. Conduct routine collaboration to address trends, share lessons learned, and promote consistency across statewide planning practices.

Mentor TDOT staff and external planning partners in areas such as MPO processes, planning grant management, and federal documentation requirements. Serve as a subject matter expert on best practices and regulatory compliance related to planning deliverables.

Perform quality assurance reviews of MPO work products and planning documents to ensure all federal and state requirements are met. Ensure that project records, datasets, and critical documentation are consistently maintained and in alignment with TDOT's performance goals and data management standards.

Develop and deliver presentations at statewide conferences, workshops, or interagency meetings; represent TDOT on planning-related policy, strategy, and process improvement topics.
