### Overview

The Tennessee Department of Transportation is currently hiring student interns for the Region 3 Environment Office located in Nashville, TN. The intern will be assigned a current TDOT project. The intern will review the project and assist in the development, maintenance, and issuance of permits for this project. The intern will attend in-office field reviews and onsite pre-construction meetings for the assigned project. The intern will also meet with project engineers and supervisors to identify the scope of work and environmental concerns relating to the development/construction of the project and discuss permitting needs. The intern will be able to provide project and permit progress during bi-weekly staff meetings. At the end of the internship the intern will have gained valuable experience in various areas of engineering, both in office and in the field. The intern will be able to present the project at the end of the summer.

### Responsibilities

- Accompany staff biologists on field visits to locate and identify ecological features; observe endangered and threatened species.
- Become familiar with state and federal permits used in the permitting process. Receive training in computer programs and websites needed during the environmental permitting process.
- Review and assess construction and roadway plans for the project.
- Receive the project assignment and identify project metrics and permitting needs.
- Attend project meetings (throughout internship) and visit project site (throughout internship) to become familiar with the physical layout of the project beyond paper plans.
- Oversee and evaluate the implementation of project and environmental permits.

### Qualifications

- Civil Engineering, or Environmental Engineering major required.
- Junior, or Senior Class Status required as of May 2024 OR recent Graduate as of Spring 2023.
- Legally authorized to work in the U.S.
- Experience with state and/or federal environmental permits, construction plans review, erosion prevention sediment control, and GIS and/or MicroStation preferred.
