

## Who we are:

The Tennessee Department of Transportation provides citizens of Tennessee and travelers with one of the best transportation systems in the country. TDOT is a multimodal agency with responsibilities in building and maintaining roads, aviation, public transit, waterways, railroads, cycling and walking. Other responsibilities include researching and implementing emerging technology and providing technical guidance; providing training, staff development, and support to Region Geodetics and other TDOT Divisions; delivery of aerial surveys and state-wide base mapping; management of the CORS network and other Geodetics systems; and collaboration with internal and external partners.

### Overview

The Tennessee Department of Transportation is currently hiring student interns for the Region 3 Geodetics Office located in Nashville, TN. These interns work with a survey crew to gain hands on training using total station, GNSS equipment, digital levels, and other survey equipment and software. The geodetics interns will work with a specialist to learn how to download and process survey field data and review data for completeness and accuracy. Training for basic MicroStation/Geopak or ORD training will be provided. The interns will meet with survey specialists and supervisors to develop a further understanding of the overall function of Survey within Project Development.

### Responsibilities

- Work with a field crew performing location surveying using total station and real-time kinematic GPS equipment, setting project control, etc.
- Complete hands-on training using total station, GNSS equipment, digital levels, and other survey equipment and software.
- Work with a specialist to learn how to import survey data into CADD software and become familiar with how survey files are developed.
- Download and process survey field data and review data for completeness and accuracy.
- Download and process survey data to create survey files.
- Review TDOT Survey Manual and TDOT Feature Codes

### Qualifications

- Civil Engineering, Surveying, or Construction Management major required.
- Junior, or Senior Class Status required as of May 2024 OR recent Graduate as of Spring 2023.
- Legally authorized to work in the U.S.
- Problem solver, teamwork driven, good communicator, critical thinker, and detail oriented.
- Experience in Microsoft products (word, excel, PowerPoint) preferred.
