Job Overview

The Right-of-Way (ROW) Outdoor Advertising/Junkyard Control Team Lead will lead, mentor, and train the Team through empowerment, communication, and delegated authority in addressing ROW Outdoor Advertising/Junkyard Control including the section's permitting and regulatory role. This position will assist the ROW Property Management/Excess Lands & Outdoor Advertising/Junkyard Control Manager and Region staff in developing statewide work plans that align with the Section's strategic vision and will effectively delegate authority and responsibility, when applicable, while ensuring the availability of resources for the ROW Outdoor Advertising/Junkyard Control Team to be successful.

This position will assist the ROW Property Management/Excess Lands & Outdoor Advertising/Junkyard Control Manager in developing and implementing department policies, discipline-specific technical guidance, procedures, and manuals to lead and support the Section in producing deliverables and implementing the Quality Assurance Program as part of the Department's Work Program. This position will assist the Section Manager and Region staff in developing and implementing ROW Division performance metrics; will supervise technical staff engaged in ROW Outdoor Advertising/Junkyard Control activities; and will implement performance plans, schedules, and budgets, ensuring expected outcomes, performance, and accountability of each team member. The ROW Lead will research national best practices to drive innovation and efficiency within the ROW Property Management/Excess Lands & Outdoor Advertising/Junkyard Control Section.

Essential Job Responsibilities

Manage resources and staff utilization and assist Project Managers in the management of external partners together with the Professional Services Division, including contracting for ROW Outdoor Advertising and Junkyard Control consultant services, negotiating contracts, reviewing consultant invoicing, developing contract scopes, managing contract tasks, and completing consultant grading.

Establish and ensure that there is a direct relationship between quality and work outcomes by assisting the State ROW Property Management/Excess Lands & Outdoor Advertising/Junkyard Control Manager in developing and implementing standards for the ROW Outdoor Advertising/Junkyard Control Team; providing oversight on Quality controls in the ROW Outdoor Advertising/Junkyard Control process; monitoring input

in IMS (Information Management System) for accuracy and timeliness; ensuring compliance with the Highway Beautification Act, the Tennessee Junkyard Control Act and other applicable Tennessee statutes; receiving and processing various permit applications; overseeing statutory requirements for vegetation control; and coordinating quality assessment/auditing units in assisting with quality control tasks as per the TDOT Quality Assurance Process with respect to the Project Delivery Network (PDN) and non-PDN activities.

Assist in the development of a Consultant Acquisition Plan (CAP) by providing strategic leadership in utilizing consultants for program and project delivery and oversee consultant activities to ensure quality products and services are provided. Serve on selection committees for professional engineering and non-engineering services. Provide support in the development of the Request for Proposal (RFP) by attending project-specific marketing meetings, determining scoring criteria, participating in project information sessions, serving as a scorer as part of the consultant acquisition process, and attending de-briefs with consultants.

Manage change, clarify the vision, take ownership of the change, communicate effectively, remain transparent, and hold yourself and others accountable throughout the process.

Participate as part of a matrix organization define ROW Outdoor Advertising/Junkyard Control related critical goals and intended outcomes; effectively coordinate with other units within TDOT proactively assess risk factors.
