Floating Maintenance Foreman Region Operations – Field Operations \$75,420 annually

Job Overview

The Floating Maintenance Foreman will provide direct supervision of floating maintenance crews in the implementation of daily activities. This role will develop, lead, mentor, and train each floating maintenance crew member through empowerment, communication, and delegated authority. This position will use department policies, standard operating guidelines, procedures, and manuals to deliver the expected outcomes. The Floating Maintenance Foreman will implement unit work plans, schedules that align with the Department's strategic vision, and will effectively delegate authority and responsibility, while monitoring the availability of materials, equipment, and resources to ensure sufficient quantities to fulfill assigned tasks, and for the floating maintenance staff to be successful. The Floating Maintenance Foreman will implement performance plans, ensuring expected outcomes, performance, and accountability of each crew member.

This position will actively direct floating maintenance operations within their unit ensuring a high-quality product is delivered within the given scope, schedule, and budget. The Floating Maintenance Foreman will seek to identify efficiencies within the floating crew operations and assist with the development and implementation of innovative best practices as appropriate.

Essential Job Responsibilities

Establish and ensure there is a direct relationship between quality and work outcomes by implementing maintenance standards. Coordinate with the Floating Team Lead in assisting with quality control tasks as per the TDOT Quality Assurance Process.

Manage change, clarify the vision, take ownership of the change, communicate effectively, remain transparent, and hold yourself and others accountable throughout the process. Lead staff to perform activities according to departmental, state, and federal laws, rules, regulations, guidelines, processes, and procedures.

Lead the floating maintenance crews in providing exceptional customer service to both internal and external customers, exercising effective listening skills, providing prompt responses, maintaining complete and accurate documentation, and communicating effectively.

Develop performance factors that ensure floating staff provide deliverables that are consistent, predictable, and repeatable, providing uniformly high levels of achievement, mitigation of risk, and an established track record of success.

Support the Transportation Worker Proficiency Program by actively reviewing and approving all module documents and records, providing opportunities for employees to obtain required training hours, and scheduling exams and demonstrations. Assist and monitor the Senior Transportation Worker in the program administration, follow up with the Assistant Maintenance Superintendent to ensure employees are progressing to expectations within the program.

Ensure proper administration, operation, and operator level maintenance of vehicle(s), such as dump trucks, trailers, pickups, loaders, pavers, milling machines, aerial devices, sweepers, rollers, forklift, skid steer, excavators, striping equipment, and other necessary equipment common in the work unit as required.

Schedule and monitor floating maintenance and facility operations to ensure floating maintenance activities align with strategic work plans. Ensure uniformity of floating maintenance and contract operations, methods, and procedures through field inspections. Make decisions considering cost, resource allocation, project prioritization and department policy. Estimate general material, labor, and/or equipment requirements for routine operations, inspects, and monitors work being performed. Complete daily work report(s) to document labor, equipment, and materials for historical tracking, audit purposes, and documentation of costs according to departmental guidelines.

Ensure materials, supplies and equipment rental purchases comply with TDOT procurement processes and requirements. Communicate, report, and supply appropriate documentation to support expenditures.

Lead staff to operate a safety-focused work environment centered on hazard recognition, risk assessment and mitigating safety issues with scrutiny of process and technology selection. Oversee the use of TDOT Policy 305-01 with Table A (PPE Guide), TDOT OHS Policies, and the Manual of Uniform Traffic Control Devices to establish floating maintenance work zones. Ensure employees attend Work Zone Safety Training, Traffic Incident Management Training, and Flagging Training and recertification as required.

Coordinate, respond, and document appropriately during roadside, work site, and other emergencies as required. Communicate with supervisors, peers, or subordinates about the purpose of lane closures, severity of incidents, status of emergency response, and other incident information as required.

Qualifications

- High school diploma or equivalent
- 5 years of demonstrated competency in roadway or highway maintenance, construction or related field.

Necessary Special Qualifications

- Possess and maintain a Class D driver's license valid to operate vehicles in the State of Tennessee.
- Possess and maintain, or obtain at their own expense and within 11 months of hire or promotion to this classification, a Class A Commercial Driver's License with an N endorsement without a Code O restriction (Code 52 restriction is allowable) that is valid in the State of Tennessee.
