Overview

The Tennessee Department of Transportation (TDOT) Environmental Division NEPA Programs Office (NPO), General NEPA Section is currently **hiring two full-time Environmental Studies Specialist Advanced in Davidson County**.

The NPO is responsible for ensuring coordination and document compliance with the National Environmental Policy Act (NEPA) and associated regulations and guidelines for federally funded projects, in association with the Federal Highway Administration (FHWA). The General NEPA Section within the NPO is primarily responsible for the development of Categorical Exclusion (CE) level NEPA documents and state level Transportation Environmental Evaluation Reports (TEER).

Responsibilities

- Development of quality, moderate to complex NEPA documents within the TDOT project development schedule
- Development of TEERs for state-funded projects
- Maintenance of detailed project files that document the NEPA decision
- Attendance of project-related meetings for assigned projects

Qualifications

- Education: Graduation from an accredited college or university with a bachelor's degree
- Experience: At least three (3) years of full-time professional experience in environmental programs, environmental studies, or cultural resources
- Substitution of Education for Experience: Graduate coursework may be substituted for the required experience on a year-for-year basis, to a maximum of two years (24 semester hours is equivalent to one year)

Experience interpreting roadway plans, technical writing, and excellent communication skills
